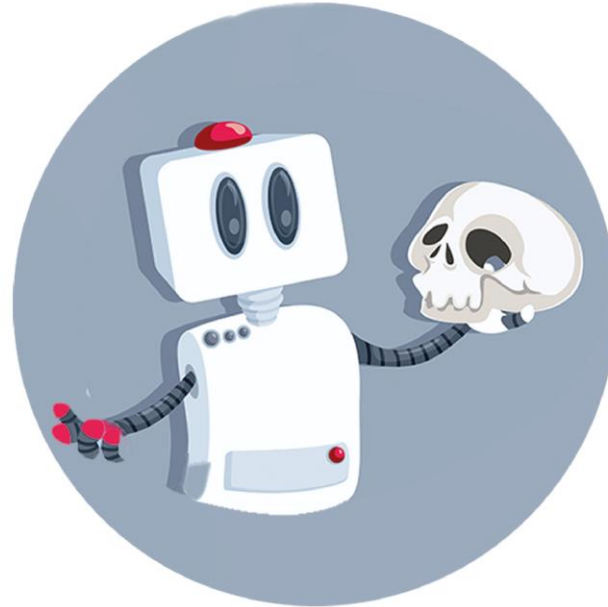
Generative AI Models: Costs vs Benefits

- Double Copyright infringement

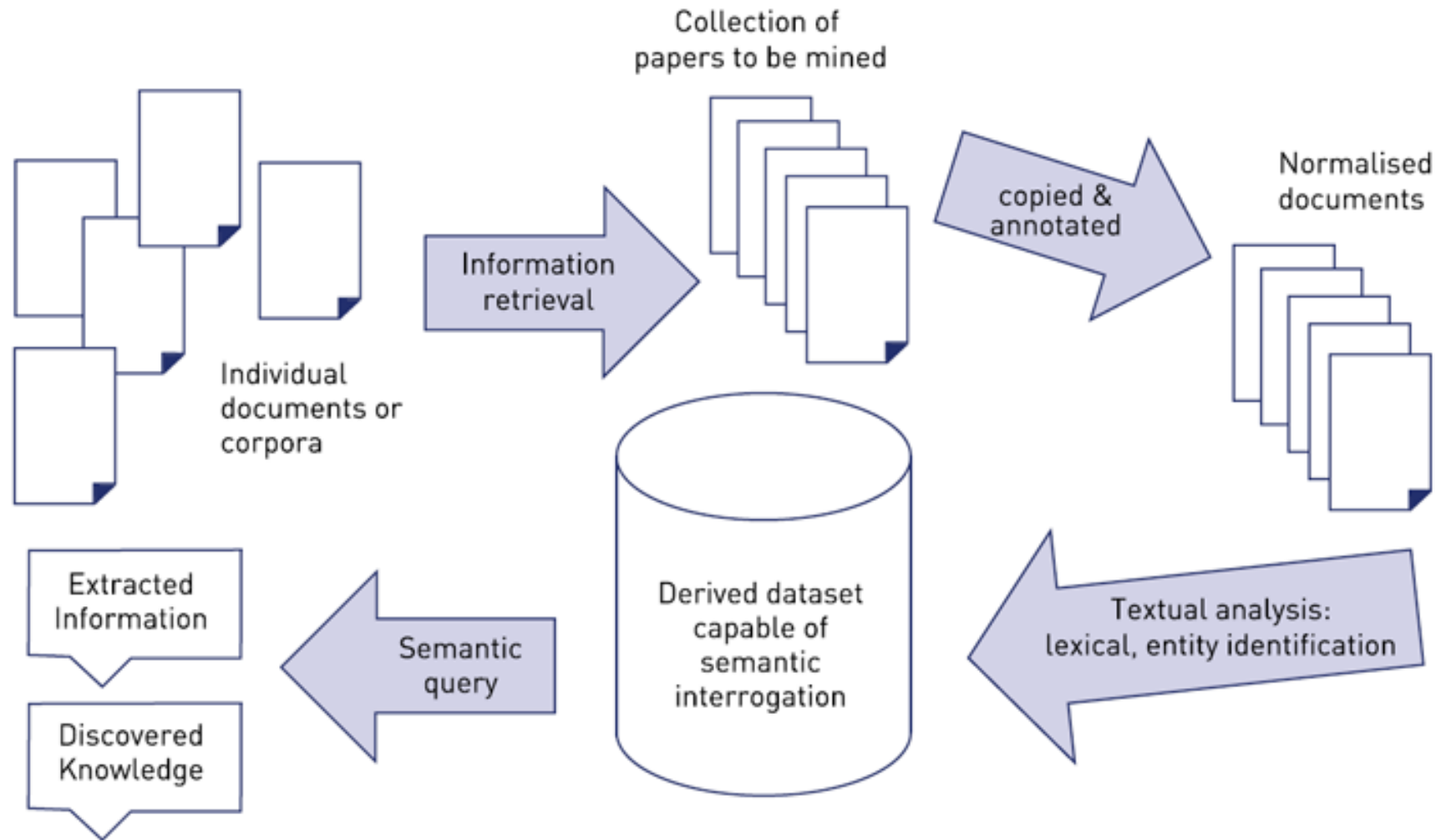

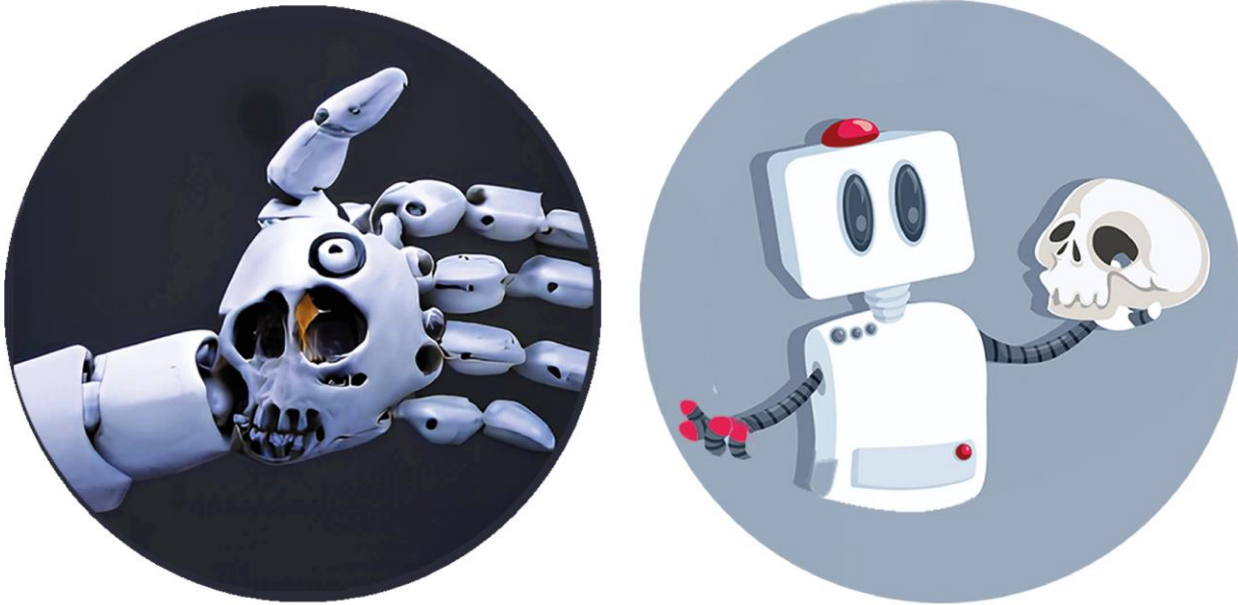
